No work, improvements, or tree removal may commence on the designated lot, until this application has been signed, approved and picked up. Any changes made to previously approved applications must be made in writing, signed and approved by the Board. This application is valid for sixty (60) days from the approval date. Applicant must resubmit the application if construction has not commenced within the sixty (60) days. The new approval process must be completed before commencing with the project.

During the construction period, Applicant and Builder are responsible jointly and severally for fulfilling the requirements set forth herein.

However, Applicant acknowledges and agrees that he is solely responsible for repairing any damage to the edges of the roadway abutting the lot and repairing any damage to any roads or landscaping caused by their contractor or subcontractor during the period of construction on the lot. Therefore, it is essential that your builder or contractor acknowledge responsibility by signing in the designated space. All contractors shall have legible lettering on their work vehicles so they can be identified. Such vehicles cannot be left on a homeowner's property between jobs. Owners are responsible for contractor's actions and notifying them of our rules and requirements.
